# CONDITIONS & FORMAT

*(To be read in conjunction with the WGNSW Standard Conditions of Play and Code of Conduct)*

## ENTRY AND CONDITIONS:

1. Open to amateur women who hold a current Golf Australia Handicap or who hold a current official handicap in an overseas country.
2. **No reductions or increases in handicap will be made during the Tournament.** Players will compete for the duration of the Tournament on the handicap current on the first day of play. Scores for handicapping (where relevant) will be returned to the players' clubs for processing after the last day of play.
3. Number of Divisions and Handicap Limits for each Division will be determined after close of entries to equalise Divisions.
4. **Ties:** these will be decided by the Golf Australia method of Countback (matching scores).
5. **Motorised Transport:** The use of Motorised Transport is permitted for all players without the need for a Medical Certificate. WGNSW accepts no responsibility for the availability of carts.
6. **WGNSW Standard Conditions of Play** will apply to this event.
